- Items selected as most valuable will be on display (in locked cases) for the duration of the Fair.
- The "Most Valuable Overall" item will be selected by the appraiser, Mr. Mike Clum, of Mike Clum Antiques.
- Entrants will be mailed a Gate 2 Load/Unload parking permit. There is a \$5.00 fee per item entered, IF entered by the above Entry Deadline.
- There is a \$10.00 fee per item entered, IF registering on the above Event Date.
- There is a \$5.00 parking fee due upon entry into designated parking areas.
- Exhibitors are asked to either establish insurance coverage for their item(s) or sign a release and waiver of liability to the Ohio Expositions Commission.
- If insurance coverage is obtained, exhibitor must declare the value of the insured item(s). An Insurance Declaration Form is required for each item, and is located at the end of the division data.
- If you are not sure which class to place your item, please consult a reputable antique dealer for assistance.
- The entry tag should be attached with a piece of lightweight string tied to part of the entry. The name and address portion of the entry tag will be covered for display during the Fair.

- Entries must be at least 50 years old.
- Age; condition; rarity; value.
